My President's comments at the last meeting got some residents riled up enough to reach out to me and that is exactly what I was hoping for. Some of them were positive, but most were not. A few weeks ago, I asked the Save the Golf Course Property Committee if they had the energy to rally as many other associations as possible in the unincorporated part of the County to launch a movement to stop the development in Citrus. They said they would accept the challenge, so you may be hearing of this in the next couple of weeks. I think we can at least slow down the Commissioner's idea of progress. Please consider supporting this effort going forward.

One last thing. The Sheriff has decided that they can't provide the required security for the Commissioners at the college where the application for homes on the golf course was to be heard, so they have moved it back to the County Courthouse and changed the date to October 24th.

Task Attorney Chapnick to Rewrite Capital Expense vs Capital Improvement/Vote Chair entertained a motion to task Michael Chapnick of Sachs, Sax and Caplan to rewrite Section 10.18 of the deed restrictions to be presented on a referendum to the community. Maggie Case so moved, Bill Miller seconded. Motion passed 5/0, all in favor.
- c. Employee bonus/Vote Chair entertained a motion to approve an additional \$100 per week to Harold Clemente retroactive to the week of July 31,2023 through September 15,2023 or until Lori Castellese returns from medical leave, whichever occurs first. Tom Russell so moved, Maggie Case seconded. Motion passed 4/1, Wayne Tuch, Bill Miller, Tom Russell, Maggie Case in favor, Sue Wassermann against.
- d. Remove Brenda Roberts from temporary chair of Fining Committee which reinstates Tom Thornton as chair/Vote - Chair entertained a motion to approve the removal of Brenda Roberts as interim chair of the fining committee and reinstate Tom Thornton as chair. Bill Miller so moved, Maggie Case seconded. Motion passed 5/0, all in favor.
- e. Nov 11 Open House/Welcome Event with Civic /Vote Chair entertained a motion to approve Civic sponsored "Welcome to Pine Ridge/Open House event" on November 11, 2023 allocating a maximum of \$750.00. Bill Miller so moved, Maggie Case seconded. Motion passed 5/0, all in favor.
- **f. Trunk or Treat Event held by Civic/Vote** Chair entertained a motion to approve Civic sponsored "Trunk or Treat event" on a date to be determined in October allocating a maximum of \$400.00. Maggie Case so moved, Bill Miller seconded. Motion passed 5/0, all in favor.
