Direct the Savings of Premiums to a Separate Account to Cover Future Repairs/placement/Vote: The chair entertained a motion to approve the business decision to not insure the following items: Stable contents, Tennis courts, Tennis and Flying Field pavilions, Pumps and Wells, Fencing, Inland Marine, Signs, Playground equipment and Gazebo. - **f.** Approve Attorneys to rewrite article 10:18 to be Included in a Future Referendum/Vote: The chair entertained a motion to approve the attorney's rewrite of article 10.18 to be included in a future referendum. Tom Russell so moved, Bill Miller seconded. Maggie Case moved to amend the motion to remove the following sentence from Sections 2 and 3: "Membership approval as required herein may also be obtained by the written consent of a majority of a quorum of the Membership." Bill Miller seconded the amendment. Amendment passed 5/0, all in favor, and amended motion passed 5/0, all in favor.

- **g. Approve Purchase of Replacement Golf Cart for Barn/Vote:** The chair entertained a motion to approve the purchase of a replacement golf cart for the barn. Tom Russell so moved, Maggie Case seconded. Sue Wassermann moved to amend the motion to select the lithium powered by Capt. Jim at \$10,340.94 minus a trade-in. Maggie Case seconded the amendment.
