- 3. New Business
  - **a. Approve hiring of replacement Administrative Assistant** Bill Miller so moved, Tom Russell seconded. Motion carried, 5/0 all in favor.
  - **b. Approve elevating Harold to Maintenance Supervisor** Bill Miller so moved, Tom Russell seconded. Sue Wassermann moved to table, Maggie seconded. Motion to table was defeated 2/3, Sue Wassermann, Maggie Case in favor, Bill Miller, Tom Russell, Wayne Tuch against. Motion was approved 3/2 Bill Miller, Tom Russell, Wayne Tuch in favor, Sue Wassermann, Maggie Case against.
  - c. Ratify President's decision to replace two toilets in the barn ladies' room Maggie Case so moved, Bill Miller seconded. Motion carried 5/0, all in favor.
  - **d.** Approve dates for two Town Hall events to explain upcoming proposed amendments to the Deed Restrictions (aka Restrictive Covenants). Bill Miller, Sue Wassermann seconded.
