

State Representatives Candidates Questions



OUESTION 1

Water

The water level in our aquifer is in decline and local springs are shrinking from outflows.

Simultaneously, we are experiencing rapid growth and development continuing well into the future.

This translates into tens of thousands of people, houses, apartments, businesses, infrastructure, public services, etc.

The rapid growth and development will demand even more water, putting our water supply at risk

As State Representative, how will you work to ensure our ground water and springs meet our water needs while maintaining healthy natural systems essential to our quality of life?

OUESTION 2

Equestrians

There are over 385,000 horses in Florida making it the third largest equine state in the country.

Because of continuing growth in Florida, there has been a significant increase in horse-and-car related incidents. The Florida Bar has noted the Florida Statute (316.0825), intended to protect equestrians, contains ambiguous language.

We need stronger direct language advising drivers how they should operate their vehicles when encountering

equestrians on roadways.

As our District 23 Representative, how will you work with Pine Ridge residents to sponsor a Bill that creates definitive language magnifying roadway safety for equestrians?

OUESTON3

Insurance

Homeowner insurance continues to be on the rise.

Some policies for owners who never had a claim have increased 50, 70 and in some instances 100%.

According to the Insurance Information Institute, Florida homeowners insurance has more than doubled over the last three years. The average Florida policy cost is 55% above the national average. In addition, many homeowners are being dropped by their insurers. Arbitrary, so called reduction methods, have rated roofs simply by age. If more than 15 years old premiums are higher or they can drop coverage.

If elected how will you represent Citrus citizens with the ongoing problem of Florida homeowners insurance?

OUESTON4

Roads

According to the Florida Department of Transportation's 2021 EV Infrastructure Master Plan, the increased use of electric vehicles (EVs) could reduce Florida's motor-fuel based revenue streams by 5.6–20% by 2040.

While all Counties need the gas revenue to service their roadways Citrus residents already know how behind we are compared to other counties.

Most of our roads are a hodgepodge of filled in holes and ruts. And this is only counting those already paved.

We need a collaborative relationship between the County and the State

If you are elected how will you begin resolving the current plight of Citrus roads---specifically how will you usher revenue toward the County to pave and resurface our roads?

OUESTION 5

Health Care

According to datausa.io, the median age of Pine Ridge residents is 65 years old.

We know anecdotally this number is moving downward based on the number of younger folks buying and settling.

Still, it is this aging population now in their sunset years that has been moving to Pine Ridge from around the country. For decades they have been carrying the taxpayer load

Many Pine Ridge seniors are at the end of financial plans established decades ago.

OUESTON6

Environment
